LOCATION

The property is situated in a prominent position on Paddock Wood High Street. Surrounding occupiers include Waitrose & Partners, Tesco Express, Paddock Wood Pharmacy and a number of restaurants and café's.

The premises is located on Station Approach, with Paddock Wood mainline train station less than 50 yards away.

Paddock Wood mainline station provides a fast and frequent train service to central London stations with a minimum journey time of around 45 minutes.

DESCRIPTION

The property comprises ground and first floor accommodation within a three-storey corner building. The ground floor was formerly arranged as a banking hall with offices, stores, and WCs, while the first floor provided additional office and ancillary storage space. The landlord has since stripped out the interior, creating an open-plan layout that provides a blank canvas for an incoming occupier to fit out to their own specification.

The property also benefits from 6 dedicated parking spaces.

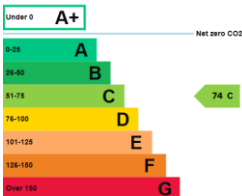

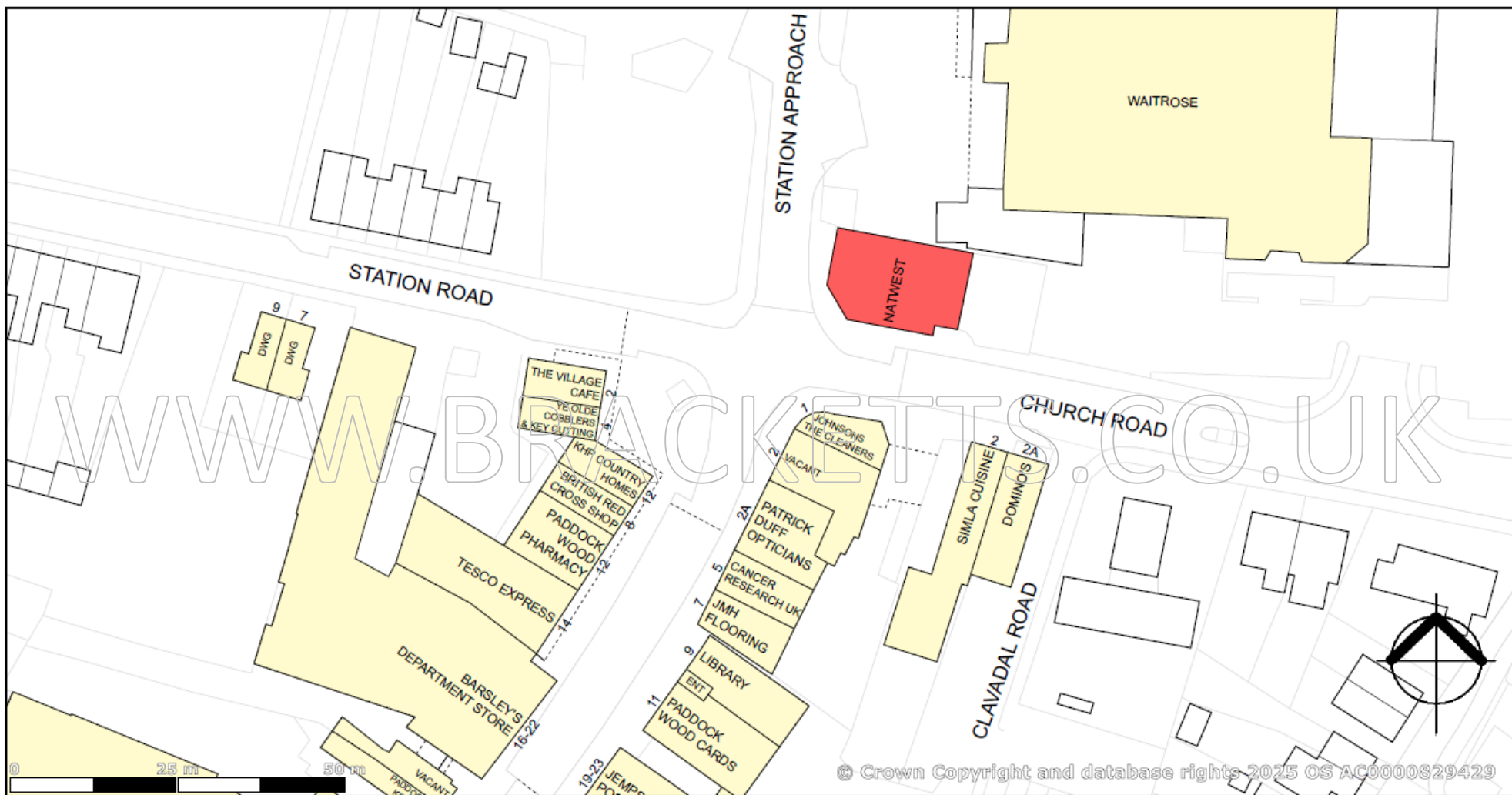
